

**STATE OF NEVADA****CERTIFICATE OF APPROPRIATION OF WATER**

**WHEREAS**, Stephen F. Turner, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for commercial (concrete batch plant) purposes. The point of diversion of water from the source is as follows:

**SW $\frac{1}{4}$  SW $\frac{1}{4}$  Section 12, T.20S., R.53E., M.D.B.& M., or at a point from which the SW corner of said Section 12 bears S. 58°56'16" W., a distance of 767.39 feet situated in Nye County, State of Nevada.**

**Under the provisions of NRS 533.425**, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Date of priority of appropriation:	<b>**October 9, 1952</b>

Description of the works of diversion, manner and place of use:

**Water is developed by means of a drilled well, 396 feet deep, 8-inch diameter casing, equipped with a submersible pump and totalizing meter, thence through a distribution system for commercial water service to a concrete batch plant with office facilities, located within a portion of the SW $\frac{1}{4}$  SW $\frac{1}{4}$  Section 12, T.20S., R.53E., M.D.B.&M., being further described as Assessor's Parcel Number 35-268-08, Nye County, Nevada.**


\*The total combined duty of water under Permit 70090, Certificate 17692 and Permit 76207, Certificate 19585 shall not exceed 14.0 acre-feet annually.

\*\*This certificate changes the point of diversion, manner and place of use of a portion of Permit 58619, which changed the point of diversion and place of use of a portion of Permit 14576, Certificate 5329; therefore, the date of priority remains the same as Permit 14576, Certificate 5329.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
