CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Arthur K. Bourne, by R. W. Prince, Agent, has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from South McFaul Creek (a tributary to McFaul Creek) through pipeline for Irrigation and domestic

purposes. The point of diversion of water from the source is as follows: in the NW 1/4 SE 1/4 of Section 11, Township 13 N., Range 18 E., M.D.B. & M., or at a point from which the S.W. Corner of said Section 11 bears S. 59° 51' W., 3,341.1 feet situated in Douglas County, State of Nevada.

Now Know YE, That the State Engineer, under the provisions of Section 72, Chapter 140, Statutes of 1913 has determined the date, source, purpose and amount of such appropriation, together with the place to which such water is appurtenant, as follows:

Post-office address: Zephyr Cove, Lake Tahoe, Nevada
* Amount of appropriation: 0.025 c.f.s.
** Period of use, from: May 1st to October 1st of each year
Date of priority of appropriation: October 24, 1929

Description of works of diversion, manner and place of use:-
A wood diversion box diverts the water, which is conveyed through approximately 800 feet of 1 inch pipe to a point in the NE 1/4 SW 1/4 of Section 11, Township 13 N., Range 18 E., M.D.B. & M., where it enters the main distribution system and commingles with the water heretofore appropriated under Application No. 9093. The water is used for general domestic purposes at the residential area located in the W 1/2 SW 1/4 of Section 15, Township 13 N., Range 18 E., M.D.B. & M., from January 1st to December 31st of each year, and is used for the irrigation of 16.96 acres in the NW 1/4 NW 1/4, 7.74 acres in the NE 1/4 NW 1/4, and 0.08 acres in the SW 1/4 NW 1/4 of Section 15, Township 13 N., Range 18 E., M.D.B. & M., from May 1st to October 1st of each year.
* The use for irrigation is limited to the amount of water decreed to this land in The Matter of The Determination of The Relative Rights In And To The Waters of McFaul Creek and Its Tributaries, in Douglas County, State of Nevada.
** Domestic use is from January 1st to December 31st of each year.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place where acquired and to the purpose for which acquired.
