CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS E. L. Cord, Rancher has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source (Well No. 12) through well, pump and ditch system for irrigation

purposes. The point of diversion of water from the source is as follows: SW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 33, T. 2 S., R. 35 E., M.D.B.&M., or at a point from which the N $\frac{1}{2}$ Corner of said Section 33, bears N. 10° 23' W., 2,176.00 feet.

situated in Esmeralda County, State of Nevada.

Now KNOW YE, That the State Engineer, under the provisions of Section 72, Chapter 46, Statutes of 1937 has determined the date, source, purpose and amount of such appropriation, together with the place to which such water is appurtenant, as follows:

Name of appropriator E. L. Cord

Post-office address Dyer, Nevada

Amount of appropriation 0.25 c.f.s., or 121.275 acre feet per season

Period of use, from March 1 to October 31 of each year

Date of priority of appropriation August 26, 1948

Description of land to which water is appurtenant:

25.00 acres in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 33, T. 2 S., R. 35 E., M.D.B.&M.

NOTE: A drilled well 446 feet deep and cased with 18 5/8 inch casing equipped with a 10 HP. G.E. Motor on a Pomona pump with a 5 inch discharge and 12 feet of 5 inch pipe conveys the water to the Circle L. Ranch ditch system.

The irrigated area in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 33, T. 2 S., R. 35 E., has been decreed 189.71 acre feet of the waters of Robinson (Leidy) Creek for the irrigation of 38.48 acres of crop land. The amount of water from the free flow of Robinson (Leidy) Creek and the supplemental supply from the above named underground source, shall not exceed 123.75 acre feet per season for the 25 acres listed above.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place where acquired and to the purpose for which acquired.
