CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Waite Bruce, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from Pole Creek or Little Rocky Canyon through pipe lines, reservoir and grid system for Municipal domestic supply purposes. The point of diversion of water from the source is as follows: NE 1/4 NE 1/4 Section 23, T. 29 N., R. 33 E., M.D.B.&M., or at a point from which the SW Section Corner of said Section 23, bears S. 42° 57' W., 5,919.70 feet. situated in Pershing County, State of Nevada.

Now Know YE, That the State Engineer, under the provisions of Section 72, Chapter 140, Statutes of 1913 has determined the date, source, purpose and amount of such appropriation, together with the place to which such water is appurtenant, as follows:

Description of works of diversion, manner and place of use:
Water is diverted by means of a drop inlet and conveyed by means of 6,323 feet of 4 inch pipe to a point where it joins a 6 inch pipe line that leads from Wright's Canyon Creek; thence by 1,079.5 feet of 8 inch pipe to a point where it joins a 4 inch pipe line that leads from Wild Horse Creek in East Horse Canyon; thence by 8,300 feet of 8 inch pipe to a point where the water from wells covered by Permits Nos. 9083 & 13100 is pumped into the system. This 8 inch pipe line joins the leg of a "Y" joint that connects with an 8 inch pipe line and a 10 inch pipe line that are laid parallel for a distance of 56,000 feet and conveys the water to a concrete reservoir, having a capacity of 957,000 gallons; thence by 26,881 feet of 12 inch pipe that connects with the grid system of the City of Lovelock, Nevada, at a point in the NE 1/4 NW 1/4 Section 26, T. 27 N., R. 31 E., M.D.B.&M. The grid system distributes the water to the places of use located in portions of Sections 26 & 27, T. 27 N., R. 31 E., M.D.B.&M.

NOTE: This certificate changes the point of diversion, manner and place of use of water heretofore appropriated for irrigation purposes under claim of vested right supported by Proof of Appropriation No. 01430 for the irrigation of 70.8 acres with a priority of 1869, by the combined flow of Wright's Canyon Creek and Pole Creek.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place where acquired and to the purpose for which acquired.
