CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, W. H. Settlemeyer has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from The Salmon River through reservoir and ditches for irrigation and domestic purposes. The point of diversion of water from the source is as follows: SE 1/4 NE 1/4 Sec. 20, T. 45 N., R. 64 E., M.D.B.&M., or at a point from which the E 1/4 corner of said Section 20, bears S. 34° 53' E., 986.9 feet. situated in Elko County, State of Nevada.

Now KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

\* This certificate changes the point of diversion and place of use of the waters from Sloughs and Depressions as set forth in the Salmon River Decree filed in the Fourth Judicial District Court of the State of Nevada, in and for the County of Elko, on March 3, 1923 and is issued subject to the provisions of the Salmon River Settlement Agreement dated May 20, 1952 between the Salmon River Canal Company, LTD., and Walter Gilmer, et al.

\*\* Water is conveyed by canal and channel to Salmon River Canal Co., LTD. Reservoir in Sec. 17, T. 14 S., R. 15 E., B.M., State of Idaho.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
