WHEREAS, R. S. Leighton, Assistant Secretary has presented to the State Engineer
of the State of Nevada Proof of Application of Water to Beneficial Use, from

Truckee River

through intake structure, pumping station & distribution system for
municipal and domestic

purposes. The point of diversion of water from the source is as follows: SE 1/4 SE 1/4 Section 10, T. 19N.,
R. 19E., M.D.B.&M.; or at a point from which the S. E. corner of said
Section 10 bears S. 69° 57' 58" E., a distance of 842.34 feet (Idlewild
situated in Washoe County, State of Nevada. Pump Station)

Now KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date,
source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of works of diversion, manner and place of use

Water is diverted from the Truckee River by means of an intake structure
& pumping station. The water is then pumped to the Idlewild treatment
plant thence into mains where it serves the place of use located within
Sections 31, 32, & 33, T. 20N., R. 20E.; Sections 4, 5, 6, 7, 8, & 9, T. 19N.
R. 20E.; Sections 35 & 36, T. 20N., R. 19E.; Sections 1, 2, 3, 10, 11, 12,
13, 14, 15, 16, 17, 20, 21, 22, 23, 24, 25, 26, & 27, T. 19N., R. 19E.,
M.D.B.&M.

*This certificate is issued subject to the terms of the permit and
changes the point of diversion under Permit No. 21001, Certificate No.
5805, which changed the point of diversion, manner & place of use under
Claim No. 278, Truckee River Final Decree in Equity Docket No. A-3
in the District Court of the United States in & for the District of
Nevada. (Point of diversion changes from Reno Power Dam under Permit
No. 21001, Certificate 5805, which changed point of diversion from
Orr Ditch under Claim No. 278).

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the
amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
