CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Mark Chilton (Agent) has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through drilled well, pump and irrigation system for irrigation and domestic purposes. The point of diversion of water from the source is as follows: Lot 11 (NW 1/4 SW 1/4) Section 28, T. 20N., R. 53E., M.D.B. & M., or at a point from which the W 1/2 corner of said Section 28 bears S. 88° 49' W., a distance of 1235.0 feet, situated in Eureka County, State of Nevada.

Now KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

\*This certificate changes the point of diversion under Permit No. 21595, hence the priority of appropriation of this certificate is the same as Permit No. 21595 and is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 4.0 ac. ft. annually from all sources.
The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
