CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, W. L. Higginbotham, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through well, pump and distribution system for municipal purposes. The point of diversion of water from the source is as follows: SW 1/4 Sec. 18, T. 20S., R. 61E., M. D. B. & M. or at a point from which the South 1/4 corner of said Sec. 18 bears S. 19° 11' 36" W. 1,386.88 feet situated in Clark County, State of Nevada.

Now KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: City of North Las Vegas
Post-office address: North Las Vegas, Nevada
Amount of appropriation: 0.50 c. f. s., but not to exceed 110.0 mg annually
Period of use, from: January 1st to December 31st of each year
* Date of priority of appropriation: September 15, 1953

Description of Works of diversion, manner and place of use:
Water is diverted from underground by well, pump and distribution system to the place of use, (see attached description), where it is used for municipal purposes.

This certificate is issued subject to the terms of the permit.

* This certificate changes the point of diversion, manner and place of use of Permit No. 15306, hence the priority of appropriation of this certificate is the same as Permit No. 15306.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.

All of Sections 1, 2, 3, 4, 5, 9, 10, 11, 12, 13, 14, 15, 16, 22, 23, 24, 25, 26, and 36; those portions of Sections 6, 7, 8, 17, 20, 21, 27, 28, 34, and 35 lying East of U. S. Highway 95; all in Township 19 South, Range 60 East, M.D.B.&M.

All of Sections 6, 7, 8; the South One-Half ($S\frac{1}{2}$) of Section 9; $S\frac{1}{2}SW\frac{1}{4}$, Section 13; all of Sections 15 through 36; all in Township 19 South, Range 61 East, M.D.B.&M.

The East One-Half ($E\frac{1}{2}$) of Section 12; all of Sections 13, 14, and 15; all of Sections 19 through 36; all in Township 19 South, Range 62 East, M.D.B.&M.
