

# THE STATE OF NEVADA CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS W. H. Blackmer, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through drilled well, pump and distribution system for municipal purposes. The point of diversion of water from the source is as follows: NE 1/4 SW 1/4 Sec. 36, T.20S., R.60E., M.D.B.&M., or at a point from which the E 1/4 corner of said Sec. 36 bears N. 89° 13' E. a distance of 2,717.5 feet situated in Clark County, State of Nevada.

Now Know YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

 Amount of appropriation 0.4 c.f.s. but not to exceed 94.36 m.g. annually  
 Period of use, from January 1st to December 31st of each year  
 \* Date of priority of appropriation May 20, 1953

Description of works of diversion, manner and place of use:  
Water is developed through a drilled well thence conveyed via a distribution system to the Las Vegas Valley Water District service area located within all of T.19, 20 and 21S., R.60E.; Sections 1 to 18, T.22S., R.60E.; Sections 19 to 36, T.19S., R.61E.; all of T.20 and 21S., R.61E.; Sections 1 to 18, T.22S., R.61E.; Sections 19 to 23, and 26 to 35, T.19S., R.62E.; Sections 2 to 11, 14 to 23, and 25 to 36, T.21S., R.62E.; Sections 1 to 18, T.22S., R.62E.; Sections 28 to 33, T.21S., R.63E.; and Sections 5 to 8, 17 to 20, T.22S., R.63E., M.D.B.&M. where it is used for municipal purposes.

This certificate is issued subject to the terms of the permit.  
\*This certificate changes the point of diversion, manner and place of use of Permit 15068 hence the date of priority of this certificate remains the same as Permit 15068.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
