CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, W. L. Higginbotham, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from Underground (Las Vegas Artesian Basin) through well, pump and distribution system for municipal purposes. The point of diversion of water from the source is as follows: SW 1/4 SE 1/4 Section 18, T. 20 S., R. 61 E., M.D.B.&M., or at a point from which the S 1/4 corner of said Section 18 bears S. 19°11'36" W., 1,386.88 feet situated in Clark County, State of Nevada.

NOW KNOW YE. That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of works of diversion, manner and place of use:

Water is diverted by well storage tank and distribution system for municipal purposes, to Sections 1, 2, 3, 4, 5, 9, 10, 11, 12, 13, 14, 15, 16, 22, 23, 24, 25, 26 and 36; that portion of Sections 6, 7, 8, 17, 20, 21, 27, 28, 34 and 35 lying E of U.S. Highway 95; all in T. 19 S., R. 60 E., M.D.B.&M.; all of Sections 6, 7, and 8, S 1/2 Section 9, S 1/2 SW 1/4 Section 13, all of sections 15 thru 36; all in T. 19 S., R. 61 E., M.D.B.&M.; E 1/2 Section 12, all of Sections 13, 14 and 15, all of Sections 19 thru 36; all in T. 19 S., R. 62 E., M.D.B.&M., all of Sections 1 thru 28 and Sections 33 thru 36, all in T. 20 S., R. 62 E., M.D.B.&M. All of Sections 1 thru 17 and all of Sections 21 thru 24, that portion of Sections 18, 19 and 20 lying east of U.S. Highway 95, a portion of the NW 1/4 NW 1/4 Section 25, all in T. 20 S., R. 61 E., M.D.B.&M.; that portion of Sections 1, 2, 12 and 13 lying east of U.S. Highway 95, all in T. 20 S., R. 60 E., M.D.B.&M.

\* This certificate changes the point of diversion and place of use of Permit 15597, hence the priority of appropriation of this certificate is the same as Permit 15597.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
