 CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, R. LeRoy Givens, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through drilled well, pump and irrigation piping system for recreation (irrigation of golf course) and domestic purposes. The point of diversion of water from the source is as follows: SW 1/4 SE 1/4 Sec. 20, T.21S., R.61E., M.D.B.&M., or at a point from which the SE corner of said Sec. 20 bears S. 75° 58' 56" E., a distance of 1401.0 feet situated in Clark County, State of Nevada.

Now Know YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

*This certificate changes the point of diversion, manner and place of use of a portion of Permit 12811, Certificate 4320, hence the date of priority of appropriation remains the same as Permit 12811, Certificate 4320.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 5.0 acre-feet per acre per year from any and/or all sources.

The water allowed under this certificate is to be commingled with that water allowed by those certificates issued under Permits 27531, 27532, 27533, 27835, 27836, 27837, 29614, 29616 and 29617 for use on the 126.9 acres described above, and with the understanding that the total amount of water allowed under this certificate shall not exceed 100.0 acre-feet per annum.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
