CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Clinton E. Stay, Asst. City Engineer has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump, storage facilities & distribution system for municipal purposes. The point of diversion of water from the source is as follows: NW 1/4 SE 1/4 Sec. 12, T.20S., R.60E. MDB&M or at a point from which the W 1/4 corner of said Section 12 bears N. 86° 46' 15" W., a distance of 2962 feet situated in Clark County, State of Nevada.

Now KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Amount of appropriation 0.20 cfs but not to exceed 100.0 acre feet per year
Period of use, from January 1 to December 31 of each year
* Date of priority of appropriation May 14, 1952

Description of works of diversion, manner and place of use:
The water is diverted by means of a drilled well, pump and motor which discharges into a 12" A.C.P. which conveys the water to 6" through 36" distribution lines throughout the North Las Vegas service district located in (see attached description).

*This certificate changes the point of diversion, manner and place of use of Permit 14285, Certificate 4283; hence the date of priority of appropriation remains the same as Permit 14285, Certificate 4283.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.

All of Sections 6, 7, 8; the South one-half ($S\frac{1}{2}$) of Section 9; $S\frac{1}{2}$ $SW\frac{1}{4}$, Section 13; all of Sections 15 through 36; all in Township 19 South, Range 61 East, M.D.B.&M.

The East one-half ($E\frac{1}{2}$) of Section 12; all of Sections 13, 14, and 15; all of Sections 19 through 36; all in Township 19 South, Range 62 East, M.D.B.&M.

All of Sections 1 through 28 and Sections 33 through 36; all in Township 20 South, Range 62 East, M.D.B.&M.

All of Sections 1 through 17 and all of Sections 21 through 24; those portions of Sections 18, 19, and 20, lying East of U. S. Highway 95; the $NW\frac{1}{4}$ $NE\frac{1}{4}$ of Section 26; all in Township 20 South, Range 61 East, M.D.B.&M.

All those portions of Sections 1, 2, 12, and 13 lying East of U. S. Highway 95; all in Township 20 South, Range 60 East, M.D.B.&M.
