CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, A.J. Evans, General Manager, has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump, and irrigation system for irrigation purposes. The point of diversion of water from the source is as follows: SE 1/4 SW 1/4 Sec. 5 T. 38N., R. 39E. MDB&M, or at a point from which the SW corner of said Sec. 5 bears S. 41° 07' 20" W. a distance of 1973 feet situated in Humboldt County, State of Nevada.

Now KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Amount of appropriation: 5,621 cfs, not to exceed 4069.44 ac-ft. per annum
Period of use, from: January 1 to December 31 of each year
