THE STATE OF NEVADA CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, V. V. Botts, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for mining and milling

purposes The point of diversion of water from the source is as follows NW $\frac{1}{4}$ SE $\frac{1}{4}$ Section 21, T.47N., R.37E., M.D.B.& M. or at a point from which the NE corner of said Section 21 bears N. 25° 31' 20" E., a distance of 3385.62 feet

situated in Humboldt County, State of Nevada

Now KNOW YE, That the State Engineer, under the provisions of NRS 533 425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows

Period of use, from January 1st to December 31st of each year

Date of priority of appropriation March 7, 1974

Description of works of diversion, manner and place of use:

Water is developed by means of a drilled well and conveyed through 6000' of 10" transite pipe and 2500' of 18" transite pipe to be used for mining and milling within the SE $\frac{1}{4}$, SE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 22, SW $\frac{1}{4}$ Section 23, E $\frac{1}{2}$ W $\frac{1}{2}$, W $\frac{1}{2}$ E $\frac{1}{2}$, E $\frac{1}{2}$ NE $\frac{1}{4}$ Section 27, NW $\frac{1}{4}$ NW $\frac{1}{4}$ Section 26 and NE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 34, all located in T.47N., R.37E., M.D.B. & M.

This certificate is issued subject to the terms of the permit.

The total combined annual duty of water allowed under this certificate and any certificate issued under Permit 28179 shall not exceed 326.77 mga.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein
