

CORRECTED CERTIFICATE**THE STATE OF NEVADA****CERTIFICATE OF APPROPRIATION OF WATER**

WHEREAS, James L. Scholl, Jr., Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for recreation and domestic purposes. The point of diversion of water from the source is as follows:

SW¹/₄ SW¹/₄ Section 1, T.22S., R.61E., M.D.B.& M., or at a point from which the SW corner of said Section 1 bears S. 22°24'24" W., a distance of 351.5 feet, situated in Clark County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of the works of diversion, manner and place of use:


Water is developed by means of a drilled well, 300 feet deep, 10-inch diameter casing, equipped with a 60 H.P. turbine pump, thence through a distribution system for recreation and domestic water service to a county park located within a portion of the SW¹/₄ SW¹/₄ Section 1, T.22S., R.61E., M.D.B.& M.

***This certificate changes the point of diversion, manner and place of use of Permit 14560, Certificate 4302; therefore, the date of priority remains the same as Permit 14560, Certificate 4302.**

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.

Now Know YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of works of diversion, manner and place of use:
Water is developed by a 300 foot deep drilled well, 10" casing, equipped with a 60 HP turbine pump. Water is pumped into the distribution system where it serves the county park, all within a portion of the SE 1/4 SW 1/4 of Section 1, T.22S., R.61E., M.D.B.&M.

*This certificate changes the point of diversion, manner and place of use of Permit 14560, Certificate 4302, hence the date of priority of this certificate remains the same as Permit 14560, Certificate 4302.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
