CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, James G. Sanders, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for irrigation

purposes. The point of diversion of water from the source is as follows: NE 1/4 NE 1/4 Section 4, T.42N., R.37E., M.D.B.&M., or at a point from which the NE corner of said Section 4 bears N. 4° 58' E., a distance of 738 feet situated in Humboldt County, State of Nevada.

Now KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

The certificate issued under this permit and Permits 29724 and 29725, total combined amount of appropriation shall not exceed 2.718 c.f.s., which is what the well is capable of producing and shall not exceed a yearly duty of 4.0 acre feet per acre from any and/or all sources.

This certificate is issued subject to the terms of the permit. *This certificate changes the place of use of a portion of Permit 26987, Certificate 8160, which changes the point of diversion of Permit 20780, therefore the date of priority is the same as Permit 20780.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
