CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, J. R. Caldwell, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for irrigation

purposes. The point of diversion of water from the source is as follows: SW 1/4 SW 1/4 Section 11, T.38N., R.36E., M.D.B.&M., or at a point from which the SW corner of said Section 11 bears S. 46° 30' W., a distance of 61.5 feet situated in Humboldt County, State of Nevada.

Now KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Amount of appropriation 0.228 c.f.s., but not to exceed 164.24 acre feet per annum
Period of use, from January 1st to December 31st of each year
\* Date of priority of appropriation July 11, 1968

Description of land to which the water is appurtenant:
The total combined number of acres under this certificate and Permits 34025, 34026, 35788, 35789 and 35790 shall not exceed 89.64 acres and are used in the following listed legal subdivision:
3.34 acres in the NW 1/4 NE 1/4 of Section 15, T.38N., R.36E., M.D.B.&M.
33.54 acres in the NE 1/4 NE 1/4 of Section 15, T.38N., R.36E., M.D.B.&M.
37.22 acres in the SE 1/4 NE 1/4 of Section 15, T.38N., R.36E., M.D.B.&M.
15.54 acres in the SW 1/4 NE 1/4 of Section 15, T.38N., R.36E., M.D.B.&M.
89.64 acres total

The total combined amount of water granted under this certificate and Permits 26798, 34025, 34026, 35788, 35789 and 35790 is limited to 5.01 c.f.s.

\*This certificate changes the point of diversion and place of use of a portion of Permit 24573, Certificate 8059, hence the date of priority remains the same as Permit 24573, Certificate 8059.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre feet per acre per annum from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
