

The above entitled matter coming on for hearing before the Court on the 17th day of January 1916, and the matter having been by the Court continued until January 22nd, 1916, at the hour of ten o' clock fore noon, and now upon this date, the matter coming on regularly for hearing, the State Engineer, being represented by M.A. Diskin, District Attorney of Esmeralda County, Nevada, and no appearance been made by any other person or persons, and it appearing to the Court from the records and files of the Court, that on the 1st day of December 1915, the Order of Determination as made by the State Engineer in said cause was duly filed with the Clerk of the above entitled Court, and thereafter and on the 7th day of December 1915, the evidence and plats in said cause was filed with the Clerk of said Court, and that on the 9th day of December 1915, an order was duly made and entered by this Court, under and by virtue of which, the above entitled matter was set down for hearing before the Court, at the Court room, in the Court house at Goldfield, Nevada, on the 17th day of January 1916, and it further appearing to the Court that the notice of said hearing was duly served upon the interested parties, as provided by law, and that no appearance was made by any person or person and that no exceptions were filed with the Clerk of the above entitled Court, to the said order made by the State Engineer as aforesaid, within the time allowed by law, and the default of Adam Patterson was duly entered in the premises.
