

QUITCLAIM DEED

THIS INDENTURE, made this 10th day of May, 1966, by and between DAVID DOTTA and ROSA S. DOTTA, his wife, of the City of Elko, County of Elko, State of Nevada, parties of the first part, and DANIEL E. KENNEDY and CAROLYN V. KENNEDY, his wife, of Elko County, State of Nevada, parties of the second part,

W I T N E S S E T H :

That the said parties of the first part, for and in consideration of the sum of ONE DOLLAR (\$1.00), lawful money of the United States of America, to them in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged, does by these presents remise, release and quitclaim unto the said parties of the second part, as joint tenants with right of survivorship, and not as tenants in common, and to the survivor of them, and to their assigns, and th the heirs, executors, administrators and assigns of the surviyor, forever, all those certain lots, pieces or parcels of land situate in the County of Elko, State of Nevada, more particularly described as follows; to-wit:

Beginning at Monument A, a concrete block with a copper center point, which bears north 57°22' east, 3751.6 feet from the southwest corner of Section 19, Township 33 North, Range 58 East, running thence south 66°37' west, 312 feet to point No. 1, thence south 69°57' west, 658 feet to point No. 2, thence south 20°03' east, 294 feet to corner No. 1, the place of beginning: thence north 69°57' East, 311.31 feet to Corner No. 2, which is the intersection of said line with the north and south center line of Section 19, Township 33 North, Range 58 East, thence south along said line 178.4 feet to Corner No. 3, which is also the southeast corner of the NE¼ of the SW¼ of Section 19, Township 33 North, Range 58 East, thence south 89°24' west, 265.68 feet, along a fence to Corner No. 4, thence north 20°03' west, 78.2 feet to Corner No. 1, the place of beginning. And also the following piece or parcel of land:

Beginning at the same point as above and running from point No. 1, south 69°57' east, 708 feet to point No. 2, thence south 20°03' east, 34 feet to Corner No. 1, the place of beginning; thence south 69° 57' west, 200 feet to Corner No. 2; thence south 20°03' east, 249.9 feet to Corner No. 3, thence north 89° 24' east, 212.2 feet to Corner No. 4; thence north 20°03' west, 320.5 feet to Cornor No. 1, the place of beginning.

TOGETHER with all buildings and improvements thereon.

TOGETHER with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD said premises, together with the appurtenances, unto the said parties of the second part, as joint tenants, and not as tenants in common, and to the survivor of them, and to their assigns, and to the heirs, executors, administrators and assigns of the survivor, forever.


