HANKINS, all of the County of Elko, State of Nevada, the parties of the first part, and HANKINS-BELLINGER COMPANY, a Corporation, duly organized under and existing by virtue of the laws of the State of Nevada, the party of the second part,

W I T N E S S E T H :

That the said parties of the first part, for and in consideration of the sum of TEN (\$10.00) DOLLARS, Gold Coin of the United States of America, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, have granted, bargained and sold, conveyed and confirmed, and by these presents do grant, bargain and sell, convey and confirm unto the said party of the second part, and to its successors and assigns forever, all those certain lots, pieces or parcels of land situate, lying and being in the County of Elko, State of Nevada, and bounded and particularly described as follows, to-wit:

The Southwest Quarter (SW $\frac{1}{4}$) of Section Eighteen (18), and the East Half of the Northwest Quarter (E $\frac{1}{2}$ NW $\frac{1}{4}$) of Section Nineteen (19), Township Thirty-three (33) North, Range Fifty-eight (58) East, M. D. B. & M.;

The Southwest Quarter (SW $\frac{1}{4}$) of Section Twenty-six (26), Township Thirty-four (34) North, Range Fifty-eight (58) East, M. D. B. & M.;

Together with all buildings and improvements situate and being upon said premises, and together with all water, water rights, dams and ditches now or heretofore used upon or in connection with said premises or belonging or appurtenant thereto.

Also Contract No. 1583-F with the Central Pacific Railway Company for the East Half (E $\frac{1}{2}$) of Section Twenty-seven (27), Township Thirty-four (34) North, Range Fifty-eight (58) East, M. D. B. & M., dated December 21, 1915, and due December 21, 1925.

TOGETHER with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD all and singular the said premises, together with the appurtenances, unto the said party of the second part, and to its successors and assigns forever.
