WITNESSETH: That the said party of the first part, in consideration of the sum of Ten (\$10.00) Dollars lawful money of the United States of America, to it in hand paid, by the said party of the second part; the receipt whereof is hereby acknowledged, does by these presents, grant, bargain and sell, unto the said party of the second part, and to his heirs and assigns, forever: All of the following described pieces and parcels of land situated in the town of Lamoyille, Elko County, State of Nevada, and bounded and described as follows, to wit:
