This letter constitutes my request for you to exercise the authority given you by N.R.S. 278.473 to make the corrections to the above referenced Parcel Map and serves as a Certificate of Amendment. The corrections are as follows:

We have determined that the Owners Certificate as shown on said Parcel Map is incorrect. The certificate as shown on the map was executed and signed by Rex E. Steninger and Dorothy B. Steninger as individuals. The parcel being subdivided on the map was deeded into their trust by document no. 586202 on file in the office of the Elko County Recorder, Elko, Nevada. Therefore, this map should have been signed by Rex Steninger and Dorothy B. Steninger trustees of the Rex and Dorothy B. Steninger Family Trust, dated November 19, 1998.

In order to correct this oversight following is a revised Owners Certificate with the correct signatures and new notary acknowledgments. In addition, under the Surveyor's Certificate paragraph 1 should read:

1. This plat represents the results of a survey conducted under my direct supervision at the instance of Rex Steninger and Dorothy B. Steninger, Trustees of the Rex and Dorothy B. Steninger Family Trust, dated November 19, 1998.

In addition the Title Block should read: Parcel Map for Rex Steninger and Dorothy B. Steninger, Trustees of the Rex and Dorothy B. Steninger Family Trust, dated November 19, 1998.






