QUITCLAIM DEED

W I T N E S S E T H:

That Grantor, for and in consideration of the sum of TEN DOLLARS (\$10.00), lawful money of the United States of America and other valuable consideration, to Grantor in hand paid by Grantee, the receipt whereof is hereby acknowledged, does by these presents remise, release and forever quitclaim unto Grantee, as joint tenants with full right of survivorship, and not as tenants in common, the survivor, his or her heirs and assigns, forever, the following described water rights permit appurtenant with that certain real property situate in the County of Humboldt, State of Nevada, to-wit:

Water Rights Permit No. 50394 issued by the State of Nevada Division of Water Resources previously appropriated under Proof 01601 waters of the Little Humboldt River and its tributaries. Source of the water is Wash O'Neal Creek for .005 C.F.S. for irrigation purposes. Proposed place of use is 1/2 acre located within the W 1/2 W 1/2 NE 1/4 of Section 33, T. 41 N., R. 39 E. M.D.B. & M.

TO HAVE AND TO HOLD, the above-described water rights permit unto the Grantee, as joint tenants with full right of survivorship, and not as tenants in common, the survivor, his or her heirs and assigns, forever.
