

Pasquale and Rita Pasquale, husband and wife of Paradise Valley, County of Humboldt, State of Nevada, the parties of the first part, and Virgil Pasquale and William Pasquale of Paradise Valley, State of Nevada, the parties of the second part, WITNESSETH: That the said parties of the first part, in consideration of the sum of Ten dollars, lawful money of the United States of America, to them in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged, do by these presents, grant, bargain, and sell unto the said parties of the second part, and to their heirs and assigns forever, all these certain lots, pieces or parcels of land situate in the County of Humboldt, State of Nevada, and bounded and particularly described as follows, to-wit: An un-divided one third each of, in and to all of Section Thirteen (13), and the east one-half of the east one-half (E $\frac{1}{2}$  of E $\frac{1}{2}$ ) of Section Fourteen (14), in Township Forty-two (42) North, Range Thirty-nine (39) East, M.D.B.& M., containing 800 acres more or less; known as the Hinkey Ranch. Also the northwest fractional quarter of Section One (1), Township Forty-two (42) North, Range Thirty-nine (39) East, M.D.B.& M., containing 158.64 acres more or less. Also all water and water rights belonging to and/or used in connection with said lands and the irrigation thereof. Known as the Mullinix Place.
