Please be notified that the undersigned have this date executed a deed of trust in favor of the Federal Land Bank of Sacramento covering certain land in Eureka County, Nevada, together with all the Trustor's right to divert 7.848 c.f.s. of underground water from a well for the irrigation of 570.5 acres of land, and for domestic purposes, evidenced by Certificate of Appropriation of Water No. 6181 (Application No. 19123) issued by the Division of Water Resources.

ALSO TOGETHER WITH the right to divert 1233.55 acre feet of water flowing in Pine Creek for the irrigation of 416.74 acres of land and 172.07 acre feet of water from Trout Creek for the irrigation of 163.45 acres of land, as allotted to C. H. Rand; <sup>00306</sup> the right to divert 351.15 acre feet of water flowing in Pine Creek for the irrigation of 125.19 acres of land, as allotted to W. S. Yates; <sup>00305</sup> the right to divert 583.32 acre feet of water from Hot Creek for the irrigation of 194.44 acres of land and 1031.76 <sup>191</sup> acre feet of water from Pony Creek for the irrigation of 343.92 acres of land, as <sup>(Hot)00302; 00308(Pony)</sup> allotted to George W. Goodfellow, all in the Decree of the Sixth Judicial Court of the State of Nevada in and for the County of Humboldt, Action No. 2804, referred to as the Bartlett Decree.

The said deed of trust, given to secure a promissory note of even date, was recorded July 6, 1981, in the Office of the County Recorder of the above referenced County, as Instrument No. 80945.
