a consideration of Six Thousand Four Hundred and No/100 (\$6,400.00) Dollars, all the  
right, title, and interest of the United States, of, in, and to the following des-  
cribed real estate situated in Pershing County, Nevada, to-wit:

THIS INDENTURE, made this 21st day of May, A. D. 1951, by and between THOMAS P. EBERT, of the City of Lovelock, County of Pershing, State of Nevada, the party of the first part, and THOMAS P. EBERT (identical with the party of the first part herein) and ELLA EBERT, his wife, of the same City, County and State, the parties of the second part,

M I N E S E E I N:

That the party of the first part, for and in consideration of the sum of TEN (\$10.00) Dollars, current lawful money of the United States, to him in hand paid, and other good and valuable considerations accruing to the party of the first part from the parties of the second part, the receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell, convey and confirm unto the said parties of the second part, not as tenants in common, but as JOINT-TENANTS, with the right of survivorship, all those certain lots, pieces or parcels of land, situate, lying and being in the City of Lovelock, County of Pershing, State of Nevada, and particularly bounded and described as follows, to wit:
