On February 25, 1963, the State Engineer issued revocable Permit 19732. The permit was issued in accordance with NRS 533.120(3) and contained the express provision "this permit...is further subject to revocation when water is available from the Las Vegas Valley Water District...".

The State Engineer issued an order revoking Permit 19732 effective March 7, 1974.

Water is available from the City of North Las Vegas for the customers of Rio Water Co., Inc. Field Investigations by the Division of water Resources reveal that the well under revoked Permit 19732 is presently being pumped and otherwise utilized for purposes of extracting underground water, notwithstanding the State Engineer's revocation order.

NOW THEREFORE IT IS HEREBY ORDERED THAT YOU AND EACH OF YOU, immediately cease and desist diversion of water from said well, bearing in mind the statutory penalty for continued use of water under a revoked permit.¹

IT IS FURTHER ORDERED that said well, under revoked Permit 19732, be plugged in accordance with Part 14 of the State Engineer's Regulations for Drilling Wells, as set forth in Chapter 534 of the Nevada Administrative Code, within thirty (30) days of the date of this Order.
