**RULING**

**FINDING OF FACT**

An application for a Nevada Well Driller's License was filed by Travis Barrow in the office of the State Engineer on December 1, 2005, together with the statutory filing fee.<sup>1</sup>

Requests for four references were mailed on December 1, 2005. Responses were received from all of the requests. The applicant was notified on January 17, 2006, by certified mail to appear before the Statewide Well Drillers' Advisory Board on February 17, 2006, at 8:00 a.m. in Las Vegas, Nevada. He appeared as scheduled and scored 71 on Part I, of the written examination, a score of 70 is passing, he passed part II, the topographic map portion of the examination, but failed part III.<sup>2</sup>

The applicant was notified on April 5, 2006, by certified mail to appear before the Statewide Well Drillers' Advisory Board on May 5, 2006, at 8:00 a.m. in Las Vegas, Nevada. He canceled this examination.<sup>3</sup>

The applicant was notified on July 10, 2006, by certified mail to appear before the Statewide Well Drillers' Advisory Board on August 10, 2006, at 8:00 a.m. in Las Vegas, Nevada. The applicant did not appear as requested nor did he notify the Office of the State Engineer that he would not appear. The Statewide Well Drillers' Advisory Board recommended denial of the application of Travis Barrow on August 10, 2006.<sup>4</sup>

**CONCLUSION**

The Sate Engineer Concludes that the applicant failed to notify the Division of Water Resources as required in the NAC § 543.282 (2) (a).


