FINDING OF FACT

An application for a Nevada Well Driller's License was filed by William Zamow in the office of the State Engineer on March 20, 2007, together with the statutory filing fee.¹

Requests for four references were mailed on March 20, 2007. Responses were received from all four of the requests. The Applicant was notified on April 2, 2007, by certified mail to appear before the Statewide Well Drillers' Advisory Board on May 4, 2007, at 8:00 a.m. in Las Vegas, Nevada. He scored 82 on Part I, of the written examination a score of 70 is passing; he failed Part II of the examination, the description of a point of diversion.²

The Applicant was notified on July 20, 2007, by certified mail to appear before the Statewide Well Drillers' Advisory Board on August 16, 2007, at 8:00 a.m. in Las Vegas. He scored 78 on Part I, of the written examination a score of 70 is passing; he passed Part II of the examination, the description of a point of diversion and failed part III.³

The Applicant was notified on October 9, 2007, by certified mail to appear before the Statewide Well Drillers' Advisory Board on November 2, 2007, at 8:00 a.m. in Las Vegas. The applicant did not appear as requested, nor did he notify the Office of the State Engineer that he would not appear. The Statewide Well Drillers' Advisory Board recommended denial of the application of William Zamow on November 2, 2007.⁴

CONCLUSION

The Sate Engineer Concludes that the applicant failed to notify the Division of Water Resources as required in the NAS § 543.282 (2) (a).
