Notice of intent to revoke Permit 46301 under authority of NRS 534.120(3)(A) was sent to the owner of record on September 18, 1989, by certified mail.

IT IS HEREBY ORDERED that Permit 46301 is revoked and no further proceedings shall be had thereunder.

IT IS ALSO ORDERED that the wells drilled under this permit be plugged in accordance with Part 14 of the State of Nevada, Division of Water Resources "Regulations for Drilling Water Wells" and that plugging be completed within 60 days from the date of this order.
