



MILTON III, being first duly sworn, depose and say that this map, consisting of one sheet, numbered from 1 to 1, inclusive, has been correctly drawn to the designated scale from field notes of a survey made by me, or under my supervision and direction, between the 6th day of December, and the 7th day of December, 1999; that it truly and correctly represents the proposed location and extent of the works used to divert water from the Humboldt River in Pershing County, Nevada by JOHN R. GOTTSCHALK for irrigation purposes under Permit Number 64771. That the point of diversion, the location, size of the diverting channel or other conduit, location and description of all measuring devices, the location and extent of lands owned or controlled by the applicant upon which water applied for under Permit Number 64771 is used, together with the area and kind of culture in each 40-acre subdivision, and the location and names of all other works or streams which are crossed by or connected with said works are fully and correctly designated thereon.

- ◆ Indicates a found 1/4 section corner, as noted.


