


TOWNSHIP 21 NORTH, RANGE 20 EAST, M.D.B. & M.



THAT THE EXISTING AND PROPOSED POINTS OF DIVERSION, THE APPROXIMATE LOCATION OF THE DIVERTING WELLS AND ALL OTHER RESERVOIRS OR BASINS, AND THE BOUNDARY OF ALL LANDS, SHOWN BY 40 ACRE SUBDIVISION, THE AREAS PROPOSED TO BE SERVED, ARE FULLY AND CORRECTLY DESIGNATED THEREON.
