Ericson, Water Rights Surveyor No. 332, on or before February 15, 1990. That it correctly represents the location of the proposed point of diversion from an underground source in Lincoln County, Nevada, by the Las Vegas Valley Water District for municipal and domestic use. I further state that the proposed point of diversion shown on this map was furnished by the Las Vegas Valley Water District under the signature of Alan F. Walter, Chief Engineer and Water Rights Surveyor. The position of the reference corner shown on this map was derived from Loran-C navigation equipment with adjustments to conform with the 1927 North American Datum as utilized by U.S.G.S. quad maps and transformed to Nevada State Plane Coordinates, East Zone. The position of the section lines shown on this map were established by transforming B.L.M. survey plats to State Plane Coordinates.




