

SURVEY NOTES:

1. The found corners tied in this survey are per the descriptions of the Dependent Resurvey of the North Boundary of T.37 N., R.32 E., by Thomas E. Haigh in 1913 and approved by the GLO in 1915. The geodetic position (GPS) of the proposed well in Section 4 is so indicated but not warranted inside of five (5) meter position accuracy.




② STD. 3 1/4" GLO BC ON 3" IP, UP 1.3'
