

DICUS AND TARYN L. DICUS FOR IRRIGATION PURPOSES. THAT THE PROPOSED PLACE OF USE, ALONG WITH ALL CHANNELS OR OTHER CONDUITS, ALL RESERVOIRS OR BASINS, THE LOCATION AND NAMES OF ALL OTHER WORKS WHICH CONNECT OR CROSS WITH THE SAID WORKS, AND THE BOUNDARY OF ALL LANDS SHOWN BY 40-ACRE SUBDIVISIONS, THE AREAS BEING REMOVED FROM IRRIGATION, ARE FULLY AND CORRECTLY DESIGNATED THEREON.

EXISTING PLACE OF USE



PROPOSED PLACE OF USE

THE PROPOSED PLACE OF USE IS DEFINED BY TRUCKEE RIVER MAP TR-049/2 (DESCRIBING THE PLACE OF USE FOR CLAIM 337/338 OF THE ORR DITCH DECREE), PREPARED BY THE NEVADA DIVISION OF WATER RESOURCES, SIGNED ON MARCH 5, 1999.

ORR DITCH - THE NE 1/4 OF THE SW 1/4 OF SECTION 17, T.19N., R.19E., M.D.B.&M., OR AT A POINT FROM WHICH THE NORTHWEST CORNER OF SECTION 20, T.19N., R.19E., M.D.B.&M. BEARS SOUTH 44°40' WEST A DISTANCE OF 3,211 FEET (PER ORR DITCH DECREE)
