


**EXISTING POINT OF DIVERSION

- PORTION OF CLAIM 185 TO BE TRANSFERRED TO WASHOE COUNTY 0.66 AC = 2.48 AF
- PORTION OF CLAIM 185 PREVIOUSLY TRANSFERRED - PERMIT NO. 74844 1.0655 AC = 4.00 AF
