



ES 2/8/08 CLAIM 72 BOUNDARY NOT THE SAME AS SHOWN ON MAP JR-023 AS REVISED 9/10/07, BUT IT DOES NOT AFFECT THE PARCEL BEING STRIPPED BY THIS APPLICATION.

ES 2/8/08 THE TITLE BOOK STATES A CHANGE OF CLAIM #72 BECAUSE ONLY CLAIM #72 IS SHOWN ON THIS MAP; HOWEVER APPLICATION 76689 ALSO INTENDS TO CHANGE CLAIM 55 AND PERMIT 11489, C. 4827 (PREVIOUSLY CLAIMS 282, 243, 280, AND 25).
