- 1. National Forest: Humboldt National Forest
- 2. Stream: Angel Creek
- 3. Authority: Organic Administration Act of 1897
- 4. Reservation Date: May 3, 1906
- 5. Purpose: Secure favorable conditions of water flow
- 6. Location of Quantification Point:
  - a. General: East side of the East Humboldt Range
  - b. Legal: NE1/4NW1/4 sec. 35, T. <sup>37</sup>~~36~~ N., R. 61 E., Mount Diablo Base and Meridian, or at a point from which the SW section corner of section 35, T. <sup>37</sup>~~36~~ N., R. 61 E. bears S 31° 30' W at a distance of 5,000 feet.
- 7. Instream Flow Claim: a continuous instream flow equivalent to an average of 2026 acre-feet per year defined and distributed as follows:
  - a. Minimum flow rates: the rate for Day 1 and for each and every succeeding day or period throughout the entire year as follows:

b. Day 1: the day that flow attains a rate of 2.80 cfs and equals or exceeds that rate for 24 hours, but in no event earlier than May 15.

8. In the event that natural flows do not attain the rates decreed above; the United States shall be entitled to the natural flows actually occurring during the time periods described above.



Instream flows are necessary at all points along the streams within the boundaries of the national forests and the quantification herein may be extrapolated to other stream reaches in this or nearby similar watersheds based on watershed area, precipitation, watershed characteristics, or combinations thereof.
