

therefore sufficient water should be left at the source for this purpose and  
not be available for appropriation. Wildlife includes game and non-game  
species (some of which are deer and antelope).  
This reserved right and other water rights for livestock grazing common to the  
same grazing allotment shall be limited to the quantity of water beneficially  
used within the allotment.  
This spring location was determined in the field with the Global Positioning  
System (GPS). Accuracy is ±15 feet.
