(20) Remarks.....Water originally developed by means of a drilled well 240 feet deep and cased with 60 feet of 8 inch casings. Equipped with a gas engine driver pump that discharges water approximately 6 miles of 10 inch pipe to a 500,000 gallon storage tank; thence by miscellaneous-sized pipeline to buildings, hydrants, shops, and other air base facilities located in portions of SECs 3, 4, 9, & 10, T 20S, R 62E, M.D.M. Well known as Rains Well was drilled in 1933. Claimed priority date of 1 January 1942. Continual beneficial usage in support of military operations. Claimed use - .90 second feet specified in permit, 434.4 acre feet. Historical records indicate water from this well may have been put to a beneficial use as early as 1933. The Air Force reserves its right to claim a 1933 priority date if this is subsequently corroborated. All wells support military operations at place of usage, Nellis AFB and support facilities.....


