G. V. Cole, the undersigned, being first duly sworn, deposes and says that the statements herein contained relative to the appropriation of water by G. V. Cole are full and correct to the best of his knowledge and belief.

(2) The means of diversion employed is Open cut and Reservoir

(5) The nature of the claimant's title to the land upon which the works are located is Recognized Grazing Rights

(7) The approximate number of animals watered by the claimant during the first year was 100 Head cattle and said watering was conducted for an approximate period of 30 days during each of the following months The entire year with the exception of December, January and February.

(8) The approximate number of animals watered by claimant in subsequent years was as follows:

(9) The amount of water which it has been necessary to divert for the said purpose has been

.05 cubic feet per second.
40 miners inches equals 1 cubic foot per second

(10) The water is diverted from its source at S. 18 Deg. 55' E. 2983 ft. feet from

the S. E. corner of Section 34, T. 5 N., R. 67 E.,
Mount Diablo Base and Meridian. Unsurveyed

NOTE—Information under (10) must invariably be given when a public corner is within 5 miles, unless the State Engineer consents to some other form of description.

(11) The works are located at Point of Diversion
Describe as within a 40-acre subdivision of public survey or by a tie in same manner as under (10)

Claimant purchased his right from his predecessors in interest who maintained their right to this water for a period of over thirty years. Water is conveyed through open cut to reservoir where it is used for watering of cattle.
