PROOF OF APPROPRIATION OF WATER FOR
STOCK WATERING PURPOSES

From Trough Spring, Name of natural water course

duly sworn, deposes and says that the statements herein contained relative to the appropriation of
water by John L. Whipple, are full and correct to the
best of his knowledge and belief.

(2) The means of diversion employed is open cut and twenty feet of 1 1/4 inch pipe

(3) The water is impounded in twenty four feet of wooden troughs.

(4) The construction of the ditch or other works was begun in about April 1905.
and completed in 1905.

(5) The nature of the claimant's title to the land upon which the works are located is

(7) The approximate number of animals watered by the claimant during the first year was 50 cattle
and said watering was conducted for an approximate period of 30 days during each
of the following months from May 1st to November 1st and about 200 head
of cattle were watered during the winter months.

(8) The approximate number of animals watered by claimant in subsequent years was as follows:

Watered about 50 head of cattle during the summer months and gradually increased the number in the winter from 200 head in 1905 to 600 head in 1925.

(9) The amount of water which it has been necessary to divert for the said purpose has been one gallon per minute.

40 miners inches equals 1 cubic foot per second

(10) The water is diverted from its source at N. 12° 30' W., 16,060 ft. feet from the South East corner of Section 36, T. 6N., R. 62 E., Mount Diablo Base and Meridian.
