PROOF OF APPROPRIATION OF WATER FOR STOCK WATERING PURPOSES

From LITTLE MUD SPRING, Name of natural water course

Through the natural channel from the spring, Name of ditch, pipe line, etc.

R. H. WINDER, the undersigned, being first duly sworn, deposes and says that the statements herein contained relative to the appropriation of water by the MURRAY SHEEP COMPANY are full and correct to the best of his knowledge and belief.

R. H. Winder makes this proof in behalf of the Murray Sheep Company as its President. If proof is not made by claimant, deponent should state on this line by virtue of what authority he represents the claimant

(1) Name of claimant MURRAY SHEEP COMPANY Address Garrison, County of Millard State of UTAH.

(2) The means of diversion employed is not diverted from the spring channel. Dam and ditch, pipe line, flume, etc.

(3) The water is impounded in drinking pools along the channel. Troughs, reservoirs, tanks, etc.

(4) The construction of the ditch or other works was begun about 1890 and completed about 1895.

(5) The nature of the claimant's title to the land upon which the works are located is Scrip.

(6) The claimant's water right was (was not) recorded in the office of the County Recorder of County, at Page of Book of

(7) The approximate number of animals watered by the claimant during the first year was don't know and said watering was conducted for an approximate period of don't know days during each of the following months

(8) The approximate number of animals watered by claimant in subsequent years was as follows:

Since 1911 this Company has watered approximately 2000 head of sheep at this spring during certain periods of each year from April 1st to November 15th.

(9) The amount of water which it has been necessary to divert for the said purpose has been
