(15) The maximum acreage irrigated in any year was 313.29 acres.

(16) The water claimed has (Strike out one not wanted) been used for irrigation each and every year since the right was initiated.

(21) The character of the soil is Sandy Loam..... The soil needs.....acre-feet
(Sandy, gravelly, loam)
per annum to properly irrigate the crops. A continuous flow of.....3.....cubic feet of water per second, during the irrigation season of.....8.....months, is needed to irrigate each 100 acres of land.

(22) Remarks: The duplication of land as shown by the four proofs under Rock, Horse, Deer and Crippen creeks is brought about by the fact that we use the waters of those creeks in combination; the combined flow of the four creeks being used to irrigate the tabulated as indicated on the map.

The total amount of water flowing in these creeks is used all year. After the spring freshets subside the quantity of water gradually decreases until there remains just enough for Stock watering and domestic.
