(7) The approximate number of animals watered by the claimant during the first year was 50, and said watering was conducted for an approximate period of 30 days during each of the following months all the months of the year

(8) The approximate number of animals watered by claimant in subsequent years was as follows:

(9) The amount of water which it has been necessary to divert for the said purpose has been *all of Spring* cubic feet per second.

40 miners inches equals 1 cubic foot per second

(10) The water is diverted from its source at S. 16° 15' W., 898 feet from the south-west corner of Section 33, T. 24 N., R. 48 E., Mount Diablo Base and Meridian.

True bearing to nearest 5 minutes distance
