This appropriation is made to clear an omission in the records at the time of the Chandler Findings when the then owner of the herein described holdings failed to make his claim for a water right, a water right having been originally granted to the lands. The chain of title of ownership of the property from the patentee to the present owner is complete. The water asked for is to cover the following described property:

" Beginning at a point one hundred feet South-west of the west bank of ditch lying along West side of County road, and at the South-east corner of M. Jensen's ranch in Douglas County, and running in a North-westerly direction one hundred feet; thence running south-west, at right angles, eighty feet; thence running in south-easterly direction, at right angles, one hundred feet, and thence running north-easterly, at right angles, along north side of Gilman Avenue, eighty feet to place of beginning. All in Section 33 Two 13 N of Range 20 East, together with all ditch and water rights and improvements thereon.
