R. H. WINDER, the undersigned, being first duly sworn, deposes and says that the statements herein contained relative to the appropriation of water by The MURRAY SHEEP COMPANY are full and correct to the best of his knowledge and belief.

R. H. Winder makes this proof in behalf of the Murray Sheep Company as its President. If proof is not made by claimant, deponent should state on this line by virtue of what authority he represents the claimant


