(10) The water is diverted from its source at N. 84° 45' E., 1780 feet from the South ( $\frac{1}{4}$ ) one-quarter corner of Section 23, T. 5 N., R. 70 E., Mount Diablo Base and Meridian.  
True bearing to nearest 5 minutes distance


