


THE STATE OF NEVADA
PROOF OF APPROPRIATION OF WATER FOR
STOCK WATERING PURPOSES



From Rock Spring
Name of natural water course

Approximately 700 head of cattle or 2500 head of sheep have been watered at this spring and ranged on the adjacent public lands and patented lands of claimant and his predecessors in interest, since the year 1871, continuously.

(9) The amount of water which it has been necessary to divert for the said purpose has been.....

(10) The water is diverted from its source at *S. 54° 55' E. 174.1* feet from
True bearing to nearest 5 minutes distance

the *N.W.* corner of Section *19*, T *39 N.*, R *19 E.*,
Mount Diablo Base and Meridian.
