

PROOF OF APPROPRIATION OF WATER FOR
STOCK WATERING PURPOSES

(8) The approximate number of animals watered by claimant in subsequent years was as follows:

Approximately 700 head of cattle or 2500 head of sheep have been watered at this spring and ranged on the adjacent public lands and patented lands of claimant and his predecessors in interest since the year 1871, continuously.

(9) The amount of water which it has been necessary to divert for the said purpose has been

(10) The water is diverted from its source at N. 14° 10' W. 1700 feet from




